### Board of Directors Service

The Board of Directors is fiduciarily responsible for all activities of the Grand County Association of REALTORS®. Directors of the Board are elected by the Primary and Secondary members of GCAR during the Annual Election held in August each year. Service begins on November 1 after the annual election. Terms for Board of Director members are currently one year. The Officers of the Board are elected by the Board of Directors, except for the Immediate Past-Chairperson who is automatically appointed at the end of their service. Officers include the Chairperson, the Chairperson-Elect, the Secretary/Treasurer, and the Immediate Past-Chairperson. There are two Directors-at-Large that round out the Board. The Board creates the strategic plan for the organization. Through committees and task forces, consisting of volunteer GCAR Primary and/or Secondary members, the Board works to accomplish the goals of

### **Nomination and Election**

Nominations are accepted annually May 1 - June 15. After June 15, additional nominations may be made by petition signed by 20% of the members of the REALTOR® members. The petition must be received by the CEO no later than 16 days prior to the Annual Membership and Election Meeting in August to be included on the ballot. Ballots are sent electronically to the REALTOR® members 12 days prior to the Annual Membership and Election meeting. The Annual Membership and Election Meeting date and slate of candidates is set during the June regular meeting on the Board and announced by July 1 to the REALTOR® members.
